

Refer A Friend Scholarship Terms and Conditions

Description

The Refer A Friend Scholarship is awarded to new or current enrolled students of Torrens University Australia ("Student Referrers") who refer a friend to also study with Torrens University ("Referee"). The Student Referrer and Referee may be offered a 25% reduction in tuition fees each for a total of two trimesters provided they both meet the eligibility requirements below. There are limited scholarships available.

Eligibility requirements

To be eligible for any scholarship with Torrens University, you must meet citizenship requirements and the entry requirements of the relevant course.

Once eligibility is confirmed and both the Student Referrer and Referee are enrolled and their census date has passed, the 25% tuition reduction will be applied to their student account for the two subsequent trimesters.

The Refer a Friend Scholarship:

- is only available to Australian citizens and permanent residents;
- is available to new or current enrolled Torrens University students;
- applies to tuition fees only;
- is not available in conjunction with any other scholarships, discounts, deductions, allowances or otherwise (and is hence applied against the full course tuition fee);
- is only available for Torrens University Australia's Diploma, Associate Degree, Bachelor, Graduate Certificate, Graduate Diploma and Master programs;
- is not available for co-delivered courses (e.g. Simon Black, Flight Centre);
- is not available for any VET courses;
- is only applicable until the course end date with extensions only considered in extenuating circumstances;
- is awarded for a specific study intake and cannot be transferred to a new start date or to another person;
- has a maximum tuition reduction of 25% per trimester (e.g. only one Refer A Friend Scholarship can be applied to any given trimester);
- is limited to two trimesters; and
- will not be applicable if the Student Referrer or Referee withdraw from their course for any reason.

Who can refer:

- If you are a newly enrolled student, you can refer a friend and be eligible for this scholarship; or
- If you are a current enrolled student, you can refer a friend and be eligible for this scholarship.



However, if you are a current enrolled student, you <u>cannot</u> refer this scholarship to another current enrolled student.

Other terms and conditions

Torrens University Australia reserves the right to alter the Scholarship Terms and Conditions at any time, without providing notice. Torrens University Australia may also change, cancel, suspend or modify any aspect of the Scholarship without notice.

The Refer A Friend Scholarship offer may be cancelled or withdrawn if students do not comply with the terms and conditions of their enrolment. The Refer A Friend Scholarship is not applicable to repeat subjects and course transfer or downgrades, and the full price will be charged on retake subjects.

It may also not apply to course transfers depending on the terms and conditions of the scholarship.

Under no circumstance will recipients be eligible for a refund, cash payment or any other compensation for the value of unused funds from the offer.

If you choose to change to an ineligible program, discontinue or withdraw (either actively or administratively) from Torrens University, you will become ineligible for this Scholarship and as a result be responsible for any fees associated with change in enrollment status for that trimester.

In all cases, the offer is at Torrens University Australia's sole and absolute discretion.
